School Description and Mission Statement

Barnard Mandarin Magnet Elementary offers students the unique opportunity to learn the Mandarin Chinese language, the fastest growing language in the world. Barnard is located in the Pacific Beach area, and is part of the Mission Bay Cluster of San Diego Unified School District. Our students in transitional kindergarten through grade 5 come to us from all over San Diego County and the states, as well as from families who have lived in the neighborhood for generations.

Our teaching staff are highly qualified and trained in teaching Mandarin as a second language.

All students are immersed in Mandarin Chinese. Transitional kindergarten receives 30–45 minutes of Mandarin immersion instruction a day. Our kindergarten follows a 80/20 percent immersion model, in which Mandarin is taught 80 percent of the day and English is taught 20 percent of the day. Grades 1–5 follow the 50/50 model. Students spend half of their day in Mandarin and the other half in English. Barnard offers a comprehensive Mandarin immersion language program, along with the integration of the 6 Ancient Chinese Arts, to complete our students' learning of the Mandarin Language. These cultural arts classes include abacus, Kuiban, calligraphy, tai-chi, arts, music, dance, and literature. Students successfully develop the ability to use the Mandarin language in a natural context, which accelerates the acquisition of the language.

Each classroom is equipped with an i21 suite (document camera, smartboard, computer devices for each student), which enables students to utilize technology as a tool to demonstrate learning through various multimedia presentations.

The blending of a world language program with a challenging English curriculum enables Barnard students to use their knowledge of diverse cultures to think critically, act globally, and become thoughtful, responsible, and successful global citizens.



#### Statewide Assessments

#### CAASPP Assessment Results

The California Assessment of Student Performance and Progress (CAASPP) tests students in English language arts/literacy and mathematics in grades 3 through 8 and grade 11. The CAASPP was piloted in 2013–14 and first administered statewide in 2014–15. The CAASPP consists of the Smarter Balanced Summative Assessments for students in the general education population.

For eligible students, the CAASPP also consists the California Alternate Assessments (CAAs) in ELA and math, which replaced the California Alternate Performance Assessment (CAPA) in 2015 and are aligned with alternate achievement standards linked to the Common Core State Standards for students with significant cognitive disabilities.

CAASPP scores are ranked according to four "performance levels": Level 1 indicates that the student has not met the standard tested; Level 2 indicates that the student has mearly met the standard; Level 3 indicates that the student has met the standard; Level 4 indicates that the student has exceeded the standard. Students scoring at Levels 3 and 4 have met state standards in that content area.

**Note:** In the tables that follow the number of students tested includes students who did not receive a valid test score; however, achievement-level percentages have been calculated using only those students who did receive valid scores.

#### School Safety Plan (2016–17)

Campus safety is the district's top priority. Principals, teachers, support staff, school police services, and community organizations work together to prevent, prepare, and respond to emergency situations. To ensure safety and security, each school has a state-mandated individual emergency response plan that is updated annually and posted on the school's website. School staff members participate in regular emergency-preparedness drills and response training. Substance abuse prevention programs are presented to students regularly. Policies and procedures are in place to address safe entry and exit of students; serious disciplinary problems; discrimination, harassment and bullying; mandated child abuse reporting procedures; and school dress codes.

Adult supervision is provided in the classrooms and outside areas before and after school, during recess and lunch, and during passing time between classes. Under the direction of the principal or site administrator, school staff members implement specific school-building

security procedures. In addition, district offices support schools by reviewing and disseminating safety requirements and information, coordinating safety-related services, and providing safety training and assistance.

The Barnard Elementary School safety plan outlines staff roles and responsibilities for responding to emergency situations. The Barnard staff continuously emphasizes safety and preparedness with students, parents, and community members. The safety plan provides direction in both prevention and intervention, and covers such emergencies as fires, earthquakes, lockdowns, and other threats. Regular safety drills are conducted to ensure quick action in the event of an emergency. This plan is on file at the school office if parents or community members wish to review its contents.

#### **Professional Development**

The district and the Board of Education have set a high priority on professional development, with the goal of providing targeted professional development to build teachers' leadership capacity and knowledge to support student learning success. The Office of Leadership and Learning collaborates with other departments to provide teachers and administrators with ongoing professional development, including improving teaching and learning related to the Common Core State Standards, educational technology, advanced studies, and leadership development. Sessions offered at various times throughout the year focus on a wide variety of professional development aimed at strengthening content knowledge to meet the needs of all learners, with an emphasis on targeting the needs of our English language learners, students with disabilities, and other struggling learners.

In addition to district-provided professional development, principals identify a schoolwide focus each year for professional development based on student needs and also to determine areas of individual growth and development. Throughout the year, teachers participate in school-based professional learning communities (PLCs) to encourage best practices and engage in shared problem solving. Teachers are provided with useful data systems that allow them to improve the learning of each student. Staff release for professional development is organized in a variety of ways on a site-by-site basis throughout the year.

#### Instruction and Curriculum

The San Diego Unified School District Board of Education has formally adopted academic standards and curriculum frameworks approved by the California State Board of Education for all subject areas. District curriculum materials, instructional strategies and supports, professional development, and student assessments are aligned with state standards and focused on ensuring that every student has access to a high-quality, rigorous, and engaging instructional program. A range of support opportunities is available for students needing additional assistance.

Barnard has a rigorous instructional program with supports designed to enable all students to meet state grade-level standards in all subject areas. Instruction is focused on critical thinking in reading and on building conceptual understanding in math. English learners receive instruction in English language development. Students in need of support or above grade level are provided with small-group and differentiated instruction to accelerate their learning. The teachers monitor students' progress and discuss each child's performance and assessments with parents at conferences and at Individualized Education Program meetings. Barnard utilizes the Better Chinese curriculum in grades K–5. This curriculum provides a balanced literacy approach in Mandarin.
