

School Facility Conditions and Planned Improvements

The school has been at its University Heights location since the early 1930s. The campus now consists of 21 permanent classrooms, three bungalow classrooms, and three support staff rooms. The school received upgrades thanks to Proposition MM, including a new state-of-the-art library building, a two-story building with 10 new classrooms, instructional support space, interior and exterior painting, new flooring and carpeting, improved access for the physically disabled, technology and electrical upgrades, window blinds, playground equipment, paving, and roofing. Our joint-use field opened in January 2011. We are proud that our community supports us in keeping our campus beautiful, safe, and clean.

Our classrooms are carefully arranged to maximize learning opportunities. Grade levels are clustered to support student and teacher interaction; each grade level has a support room where students can receive additional help. Lunches and recesses are staggered to support student interaction and adequate supervision, and students in preschool and kindergarten play on a dedicated yard for their safety. Our PTA and after-school programs work diligently to support and maintain our beautiful school gardens across campus. Our classrooms are cleaned several times a week by our custodial staff, and provided with instructional resources through our categorical funding. Our facility is kept in good repair by the custodial staff in direct communication with the principal. Work orders, supply orders, and requests for service are tracked via a system set up with the district office.

Statewide Assessments

CAASPP Assessment Results

The California Assessment of Student Performance and Progress (CAASPP) tests students in English language arts/literacy and mathematics in grades 3 through 8 and grade 11. The CAASPP was piloted in 2013–14 and first administered statewide in 2014–15. The CAASPP consists of the Smarater Balanced Summative Assessments for students in the general education population.

For eligible students, the CAASPP also consists the California Alternate Assessments (CAAs) in ELA and math, which replaced the California Alternate Performance Assessment (CAPA) in 2015 and are aligned with alternate achievement standards linked to the Common Core State Standards for students with significant cognitive disabilities.

CAASPP scores are ranked according to four "performance levels": Level 1 indicates that the student has not met the standard tested; Level 2 indicates that the student has met the standard; Level 4 indicates that the student has exceeded the standard. Students scoring at Levels 3 and 4 have met state standards in that content area.

Note: In the tables that follow the number of students tested includes students who did not receive a valid test score; however, achievement-level percentages have been calculated using only those students who did receive valid scores.

Our school is named for the co-founder of the national Parent Teacher Association, Alice McLellan Birney, so we strive to provide meaningful experiences for parents. Our PTA also hosts a yearly "Passport to Adventure," during which we feature six countries students want to celebrate. Finally, our Friends of Alice Birney Foundation (FOAB) funds our school enrichment "specials" as well as our library program.

School Safety Plan (2016–17)

Campus safety is the district's top priority. Principals, teachers, support staff, school police services, and community organizations work together to prevent, prepare, and respond to emergency situations. To ensure safety and security, each school has a state-mandated individual emergency response plan that is updated annually and posted on the school's website. School staff members participate in regular emergency-preparedness drills and response training. Substance abuse prevention programs are presented to students regularly. Policies and procedures are in place to address safe entry and exit of students; serious disciplinary problems; discrimination, harassment and bullying; mandated child abuse reporting procedures; and school dress codes.

Adult supervision is provided in the classrooms and outside areas before and after school, during recess and lunch, and during passing time between classes. Under the direction of the principal or site administrator, school staff members implement specific school-building security procedures. In addition, district offices support schools by reviewing and disseminating safety requirements and information, coordinating safety-related services, and providing safety training and assistance.

Student safety is a top priority at our school. We have a fenced campus with access through our office during school hours. Our students enter and leave campus through our main gate, and are supervised before and after school. All visitors during school hours must enter through the office, where they must sign in and receive a visitor's pass. Birney maintains a safe, friendly environment with a secured campus and regular safety drills. Teachers and students respond quickly, responsibly, and respectfully to calls for emergency drills. Every classroom teacher provides a grade-level-specific set of lessons in problem solving, anger management, and empathy training from kindergarten through grade 5. The staff is trained yearly on child abuse reporting procedures. Our website includes information about dress code and behavior policies.

Other Information

The district's general fund includes monies for:

- · General operations—salaries, benefits, services, materials, and support to the general education
- Special Education—programs offering appropriate, individualized instruction to students with special needs
- Special projects—monies from agencies (federal or state) earmarked for specific programs/projects or services
- Transportation
- Maintenance and operations
- District administration

Each school in the district receives an instructional budget based on enrollment, programs, and formulas set by Board of Education policy, state law, agreements with employee bargaining units, and guidelines of outside funding sources.

Our students are supported in a variety of ways for both academic support and academic enrichment. Our Student-Teacher Enrichment Program (STEP) releases teachers once a week to work together while their students rotate through physical education, art, Spanish, gardening and/or computer courses, and the library. Our Learners Equally Achieving Proficiency (LEAP) structures provide students with the opportunity to receive targeted instruction in either English language or mathematics according to their need, with the additional support of our English learner support teacher and our reading specialist. All our teachers in grades 3–5 are certified, or are receiving training to become certified, to provide instruction in the Gifted and Talented Education (GATE) program.

Professional Development

The district and the Board of Education have set a high priority on professional development, with the goal of providing targeted professional development to build teachers' leadership capacity and knowledge to support student learning success. The Office of Leadership and Learning collaborates with other departments to provide teachers and administrators with ongoing professional development, including improving teaching and learning related to the Common Core State Standards, educational technology, advanced studies, and leadership development. Sessions offered at various times throughout the year focus on a wide variety of professional development aimed at strengthening content knowledge to meet the needs of all learners, with an emphasis on targeting the needs of our English language learners, students with disabilities, and other struggling learners.

In addition to district-provided professional development, principals identify a schoolwide focus each year for professional development based on student needs and also to determine areas of individual growth and development. Throughout the year, teachers participate in school-based professional learning communities (PLCs) to encourage best practices and engage in shared problem solving. Teachers are provided with useful data systems that allow them to improve the learning of each student. Staff release for professional development is organized in a variety of ways on a site-by-site basis throughout the year.

Instruction and Curriculum

The San Diego Unified School District Board of Education has formally adopted academic standards and curriculum frameworks approved by the California State Board of Education for all subject areas. District curriculum materials, instructional strategies and supports, professional development, and student assessments are aligned with state standards and focused on ensuring that every student has access to a high-quality, rigorous, and engaging instructional program. A range of support opportunities is available for students needing additional assistance.

At Alice Birney Elementary, all state-mandated standards are gathered under six overarching themes: Who We Are, Where We Are in Place and Time, How We Organize Ourselves, How We Express Ourselves, How the World Works, and How We Share the Planet. Instructors at each grade level design units of inquiry that address a theme while meeting the state requirements for addressing the standards. Any standards that cannot be addressed within a theme are treated as a "stand-alone" area. In addition to the Program of Inquiry, students also receive explicit instruction in the IB Learner Profile and the IB Attitudes. We also offer weekly instruction in Spanish, the arts, gardening, and physical education. Our special needs programs are integrated with the general population as much as possible.
