#### School Description and Mission Statement

Torrey Pines Elementary is located high on a bluff overlooking the Pacific Ocean. Our proximity to the University of California, San Diego (UCSD), provides an opportunity for collaboration with an institute of higher learning. We provide a rigorous academic environment to children in grades TK–5. Our teaching staff uses researched teaching methodologies that advance each student to his or her next level of success in all academic areas. Our mission is to provide an environment conducive to student learning in which each child feels successful, achieves academically, and thinks critically, and in which administrators, teachers, parents, and the community work together to create and maintain a comprehensive curriculum based on student needs and state standards.

We continue to perform at a very high level on state assessments of student achievement. Since the state began the Academic Performance Index (API), Torrey Pines has always been above the state and district averages. Torrey Pines' 2012 API ranking was 10 out of a possible 10, putting the school in the top 5 percent of all elementary schools in California. Our 2013 API score of 984 placed us as the highest performing elementary school in San Diego County for the second year in a row.

When measuring proficiency in the core subject areas—reading, mathematics, and science—Torrey Pines' students excel. 90 percent of the students are proficient or advanced in English-language arts and 83 percent in mathematics on the California Assessment of Student Performance and Progress. Students scored 90 percent in science. Low class sizes, a strong Gifted and Talented Education (GATE) program, and a variety of student supports help all of our students achieve both socially and academically. Torrey Pines was recently honored as a California Distinguished School and a National Blue Ribbon School.



#### School Facility Conditions and Planned Improvements

Torrey Pines is proud of its clean and safe campus. La Jolla Youth Sports, Inc., and the City of San Diego were instrumental in developing a joint-use facility in 2001. In 2002, the San Diego Padres helped fund a Little Padres Park located at our school, which is specifically designed for girls' softball.

Improvements and upgrades funded through Proposition MM have been completed at Torrey Pines. Improvements included a new library, classroom buildings, instructional support space, a lunch-court shelter, interior and exterior painting, flooring and carpeting, improved access for the physically disabled, technology and electrical upgrades, window blinds, paving, and roofing.

The district's mobile maintenance crew visits Torrey Pines annually to repair, paint, and maintain the site. The school was painted in 2014.

A campus beautification plan is on-going. With the support of parents we have recently added a quad area, planted over 15 trees, and have upgraded our kindergarten playground. A new urban garden has been created where students grow fresh flowers, fruits, and vegetables. In spring 2016 students began using a newly installed weather station to monitor, compile, and extract environmental data. We also added a greenhouse to our garden.

#### Statewide Assessments

#### CAASPP Assessment Results

The California Assessment of Student Performance and Progress (CAASPP) tests students in English language arts/literacy and mathematics in grades 3 through 8 and grade 11. The CAASPP was piloted in 2013–14 and first administered statewide in 2014–15. The CAASPP consists of the Smarter Balanced Summative Assessments for students in the general education population.

For eligible students, the CAASPP also consists the California Alternate Assessments (CAAs) in ELA and math, which replaced the California Alternate Performance Assessment (CAPA) in 2015 and are aligned with alternate achievement standards linked to the Common Core State Standards for students with significant cognitive disabilities.

CAASPP scores are ranked according to four "performance levels": Level 1 indicates that the student has not met the standard tested; Level 2 indicates that the student has met the standard; Level 3 indicates that the student has met the standard; Level 4 indicates that the student has exceeded the standard. Students scoring at Levels 3 and 4 have met state standards in that content area.

**Note:** In the tables that follow the number of students tested includes students who did not receive a valid test score; however, achievement-level percentages have been calculated using only those students who did receive valid scores.

#### School Safety Plan (2016–17)

Campus safety is the district's top priority. Principals, teachers, support staff, school police services, and community organizations work together to prevent, prepare, and respond to emergency situations. To ensure safety and security, each school has a state-mandated individual emergency response plan that is updated annually and posted on the school's website. School staff members participate in regular emergency-preparedness drills and response training. Substance abuse prevention programs are presented to students regularly. Policies and procedures are in place to address safe entry and exit of students; serious disciplinary problems; discrimination, harassment and bullying; mandated child abuse reporting procedures; and school dress codes.

Adult supervision is provided in the classrooms and outside areas before and after school, during recess and lunch, and during passing time between classes. Under the direction of the principal or site administrator, school staff members implement specific school-building security procedures. In addition, district offices support schools by reviewing and disseminating safety requirements and information, coordinating safety-related services, and providing safety training and assistance.

Torrey Pines campus is locked during the school days. The school is only accessible from the front office. We have running club that is supported by the parent foundation and parent volunteers every morning starting at 8:00 am when students are allowed to arrive on campus. We also have teacher supervision before school. The grade 5 safety patrol is on duty before and after school to support student safety walking to and from school. All students have access to the school after school hours, with parent supervision. We also are in partnership with the YMCA, which provides before- and after-school programs.

#### Professional Development

The district and the Board of Education have set a high priority on professional development, with the goal of providing targeted professional development to build teachers' leadership capacity and knowledge to support student learning success. The Office of Leadership and Learning collaborates with other departments to provide teachers and administrators with ongoing professional development, including improving teaching and learning related to the Common Core State Standards, educational technology, advanced studies, and leadership development. Sessions offered at various times throughout the year focus on a wide variety of professional development aimed at strengthening content knowledge to meet the needs of all learners, with an emphasis on targeting the needs of our English language learners, students with disabilities, and other struggling learners.

In addition to district-provided professional development, principals identify a schoolwide focus each year for professional development based on student needs and also to determine areas of individual growth and development. Throughout the year, teachers participate

in school-based professional learning communities (PLCs) to encourage best practices and engage in shared problem solving. Teachers are provided with useful data systems that allow them to improve the learning of each student. Staff release for professional development is organized in a variety of ways on a site-by-site basis throughout the year.

Professional Development is essential for principal and teacher growth. We use district resources, consultants, and resource teachers to engage in professional learning on an ongoing basis.

#### Instruction and Curriculum

The San Diego Unified School District Board of Education has formally adopted academic standards and curriculum frameworks approved by the California State Board of Education for all subject areas. District curriculum materials, instructional strategies and supports, professional development, and student assessments are aligned with state standards and focused on ensuring that every student has access to a high-quality, rigorous, and engaging instructional program. A range of support opportunities is available for students needing additional assistance.

We provide comprehensive education and a rigorous academic environment to children in grades TK-5. Our teaching staff uses researched teaching methodologies that advance each student to his or her next level of success in all academic areas. We provide the teaching staff at each grade level with a collaborative planning opportunity. Our mission is to provide an environment conducive to student learning in which each child feels successful, achieves academically, and thinks critically, and in which teachers, students, administrators, parents, and community members work together to create and maintain a comprehensive curriculum based on student needs and state standards.
